Democratic breakthrough

- 1917 Parliamentary government
- 1918-1921 Universal and equal suffrage
- 1922 First women in parliament

But only minor changes in the constitution

The Riksdag Act, art. 16

Instrument of Government

Codify the unwritten constitution


Controversy

Bill of rights?




Partial reform 1970

Constitutional commission II 1966–1972

Grundlagberedningen

Partial reform

One chamber with 350 members (later 349)
Proportional election system, 4 % threshold
Election period 3 year (later back to 4 years)
Simultaneous elections: national, regional, local
Parliamentary government: vote of no confidence




